## 3. Matters arising from previous minutes.

- a. There was no update on the details of the defibrillator for Farnell, with regards to location and power source. This was due to no residents of Farnell being in attendance.
- b. There was no update on the details of the Farnell Stone, or location for it to be sited. (RB) stated that, only when these details are complete, by residents of Farnell, can the community council provide assistance with regards to transport and any other issues that may arise.
- c. The issue of Dog waste bins sited in the area was to be raised to the councillors. However, as none attended, we will raise this to them again at the next meeting.
- d. (RB) proposed (RC) to the community council position of TEAMS leader. This position will be more prevalent in the winter meeting months of, October, December and February. This position will need the support of (KT) due to finance requirements. (RC) accepted taking this position. The proposal was seconded by (KT).

- e. (KT) was asked if there was any progress on finding out how many 'clicks' had been on our section of the Aberlemno.org website. It was revealed that the engagement details of the website were not activated. This has now been amended.
- f. The community council would like to thank the Angus Council Roads Dept for the 'SLOW' signage painted onto Church Road leading to the Aberlemno church, from both directions.

d. (RK) asked if the community council would support rubbish bins to be sited in the laybys on the B9134. Initially, at the Forfar end of Aberlemno and at the top of Hill of Angus. This has been mentioned before in another meeting and will now be put forward to the Local Councillors.

## **Treasurers Annual Report**

## April 2023 – end March 2024

The last year has been a reasonable year for financial matters and all our invoices and payments are up to date. The end of year accounts have been prepared, audited and sent to Angus Council.

- Received a grant of £375 which is restricted funds, for the running of the Community Council.
- The Special Meeting on 15<sup>th</sup> June 2023 was paid for from 'unrestricted' funds as this was a chance for all residents to state their opposition to the pylons and OHL's. The payments covered Village Hall hire and printing costs.
- No requests have been received from members of the public regarding small donations from the 'unrestricted' funds which can be used for small community projects.
- The 'unrestricted' fund stands at £452.
- Stationery, venue hire and contribution of 50% towards the Aberlemno.org website continues to be the biggest expenses over the year.

As you may or may not be aware that I am resigning my post as Treasurer, so my thanks go to the residents, Auditor Vicky Hepburn, Angus Councillors and my other Colleagues on the Community Council for all their help and advice, over the last 2 years. #### Special Meeting - ABERLEMNO VILLAGE HALL, 7PM ON 15 JUNE 2023

The special meeting was held in response to residents request and was called to discuss the CC response to SSEN proposals for East Coast 400kV Phase 2 as it affects the Community Council area.

After a brief introduction by the Chair, comments and concerns were requested for the CC to take forward in their official response to the consultation.

#### Update

A comprehensive response was drawn up and submitted by Lynn Bruce.

Subsequently the proposals affecting the Aberlemno and District Community Council area were amended and the pylon corridor moved north of the A90. Whilst this removed direct concerns, Community Council members have kept up with public participation and community groups developed in response to these proposals. Support for fellow communities continues and objections in principle remain unresolved. We will comment on, object to or support proposals as Council members and residents see fit.
